TERMS AND CONDITIONS

1. The execution of the work will be done on Turn-key basis.
2. Tools and plants required are to be arranged/ supplied by the contractor himself and at his own cost.
2. Construction materials mentioned in the specifications of items of ISI approved will have to be supplied/ installed/installed by the contractor at site conformity to the specification and satisfaction to the Engineer-in charge. Sub standard materials will not be allowed to use in any circumstances.
3. Curing of construction to be done properly and labour and water including lead and lift required shall have to be arranged by the contractor himself.
4. No extra payment for carrying of materials including lead and lift other than mentioned in the items will not be considered in any circumstances.
5. Alloted work has to be done within three months from the date of issue of the work order.
6. The contractor will be allowed to make arrangement for storing of construction materials in the council premises. However, the office authority will not be liable to take any risk/ responsibility of the same.
7. 10% Security deposit including 2% Earnest Money will be released after six months of the successful completion of the allotted work.
8. Estimate is prepared as per schedule of Rates for P.W.D. buildings(Civil works) 2010-11.
9. Selected party will have to sign in F-2 form before issue of final work order.
10. All applicable taxes will be deducted at source against which , necessary tex deduction certificates will be issued from this office as and when necessary .
